It is critical that household products, designated as regulated products, meet the specified safety standards to help ensure consumers safety and peace of mind. The objective of the Emirates Authority for Standardization & Metrology or ESMA Scheme is to safeguard consumers' interest. UL is recognized by Emirates Authority for Standardization & Metrology as a Notified Body (NB) for issuing ECAS/EQM Certification for different types of regulated products.

Registration of Regulated Products:

Suppliers with regulated products who wish to enter the UAE market first need to have a local trade license to sell the regulated products in the local market.

The local agent shall submit an application to the Notified Bodies (UL Middle East office) for ECAS or EQM certification issuance.

After the regulated products have been successfully reviewed, the NB (UL Middle East Office) shall issue a Certificate of Conformity (CoC) to the local supplier.

The local supplier or the NB (UL Middle East office) shall submit via online the CoC to ESMA to request the energy labels (when applicable).

In cases where there are modifications to the regulated product, the local supplier is required to inform the NB (UL Middle East office) or ESMA.
